Commission Notes

The annual organizational meeting of the City Commission was Jan. 2. After Ann Crichton and Steve Johnson were sworn in for their new two-year terms, they were named as Chairman (Mayor) and Vice-Chairman, respectively.

(traffic cases); Tom Davis, City
Attorney; Gary Martin, School
Board; Bill Breen (of Winnona Dr.),
Planning Commission; Joy Jackson
(of S. Candler St.) and Carter
Wilson, Recreation Board; and Mike
Mears, Board of Appeals.

Ellen Perry (S. Candler), Joy Jackson, and Martha Hollis (Mimosa Dr.) were the Winnona Park residents among the fifteen people appointed to the Community Goal Committee. These appointments were made to comply with federal regulations requiring citizen participation in the community development program.

The Commission tabled an application from Columbia Seminary regarding rezoning of its property. Seminary plans include building more student housing; the Commission wanted more information before giving their approval.

On January 23, the Commission raised attendance fees for planning commission members, approved a beer and wine license for a sandwich shop on Clairmont Avenue; and voted to discontinue registration of dogs, due to the expense. (Rabies innoculations are still required.)

Mayor Crichton then read a directive, issued to all Boards and Commissions, that instructed them to elect a chair, set regular meeting dates, and post meeting dates with an agenda at City Hall and the Police Station. Regarding members attendance, the Mayor said that three absences from official meetings would be considered as a resignation.

She also emphasized the importance of the Boards and Commissions and expressed appreciation to those serving on them. (By Martha Hollis)



Historic Decatur



Since last spring, representatives of our Winnona Park neighborhood, the South Decatur Community Council, and other interested neighborhood citizen groups have been meeting and working on a variety of tasks related to the historical aspects of South Decatur.

During the coming months, we'll be bringing you informational notes through this newsletter on some important projects that affect you!

This issue's article is general in nature, to tell you about Historic Decatur itself. H.D. projects are two-fold: (1) Being concerned and responsive to all planning that will affect our neighborhood and its rich historic resources (including its people and its property); (2) specifically working toward preservation of our neighborhood's historic properties.

So, we have formed two task forces which are working on these items, yet together as a whole for an integrated neighborhood approach.

H.D. meets every other Saturday morning at 10:00 A.M at differing locations here in our area. It's a citizen group, not connected with any public agency and always open to the public.

Future articles will talk about historic preservation methods, the National Register for Historic Places, the transportation task force - each as they apply directly to us in Winnona Park.

One final note - the importance of the work of Historic Decatur lies in the fact that history is not dead, but very much alive and part of our lives. That is never truer than here in Winnona Park! See you next month.
