To make a few dollars go far, the ark, dubbed S.S. Winnona, will be constructed of donated and recycled materials by volunteers from the community.

The PTA is anxious to involve interested members of the whole community to develope a park to meet the recreational needs of all ages. Numerous alternatives are now being discussed, such as park benches, a picnic area, landscaping, running track, trees and improvement of present facilities.





Historic Decatur



One of the fun things in working on Historic Decatur's nomination to the National Register is the history of our local neighborhood that is being gathered, fitted together, and told to us as anecdotes.

Weaving a latticework of culture, people, and places is like finding a long-lost album of family pictures. It causes us to pause a bit and reflect on times and memories past.

Chris Gleckner, a Georgia State student, has put together a 14 page synopsis of South Decatur's historical significance for Historic Decatur's nomination application.

In interviewing our local historian, Caroline Clarke, who lives on Candler Street, Chris writes of our 19th century "developers" - four men who originally owned most of the land that we now call South Decatur. They are: Milton Candler, Dr. James Avery, Dr. Thomas Chivers, and Dr. Peter Hayle.

Candler's original holding of 250 acres was at the southern end of Candler Road, and his rebuilt farmhouse still stands on the south side of Kirk Road at the Avery Street junction.

Dr. Avery owned the land north of Candler to Columbia Drive. Dr. Hayle owned land to the west of Candler Street where Agnes Scott now is built.

And Dr. Chivers' claim to fame, reports Franklin Garrett, Atlanta Historian, is being a contemporary friend and rival of Edgar Allen Poe. Chivers accused Poe of stealing his theme and style to use for "The Raven". Dr. Perry, President of Agnes Scott, tells us Chivers' tombstone marker can still be found on the Agnes Scott campus.

We look forward to more of these "slices from the past" as you each share your stories with us and your neighbors. What ghost haunts around the next corner? What event reveals the rationale for that peculiar window in that particular place? Who built and lived in my house in 1920?

News Briefs

Our May 6 Picnic/Meeting included good food, a good turnout and no rain. Guests included State Senator Bud Stumbaugh, County Commissioner Liane Levitan, New Era News Editor Rod Deremer, and Quinn Hudson, President of Atlanta Great Park Planning,

It was announced that 25 families had participated in the WPNA sponsored neighborhood-wide yard sale. It is hoped that this can be repeated on a yearly

The situation surrounding the expansion of the North DeKalb Wrecker Service was discussed. As you know now, neither this association nor the city has been able to prevent its expansion onto Avery

The Association adopted a policy to not endorse any candidate for public office; and further, that if a WPNA officer wins an election, that he or she must resign his or her WPNA office.

WPNA endorsed the idea of a community credit union, which is being formed under the name of Decatur Community Credit Union.

WPNA Executive Board has endorsed the concept of an adaptive re-use of the Scottish-Rite Hospital as a multi-use Community Center, in a letter to Mr. William H. Denton, East Lake Project Coordinator.

Gordon Anderson of Shadowmoor Drive was recently appointed to the Planning Commission, which has been recently expanded from 5 to 7 members.

Catherine Carter of South Candler Street was appointed as Decatur's representative to the Georgia Municipal Association task force on Energy and recently attended a task force conference in Athens.

Paper Drive

Paper drives will once again be a vital part of this year's PTA budget. However, changes in the paper company's policy will make this year's efforts more difficult. A minimum of 10,000 pounds is required before the school will receive top dollar.

The 10,000 pound requirement is a tall order requiring maximum effort each month. It has been reached before, although some months the drive has fallen below that mark.

Scottish Rite

Community residents and friends have taken important steps toward "turning on the lights" at the old Scottish Rite Childrens Hospital on Hill Street. Most recently a board was elected to govern the Community Center proposed for that site. Winnona Park representatives include Lyn Deardorff, Martha Hollis, Bob Leitch, and Ellen Perry.

Representing the South Decatur Community Council are Lewis Bayles, Susan Bishop, Rob Rosenbloom, Johnny Swanson, and Leonard Thrower. Among friends of the community, Norman Coffman, Evelyn Green, Eleanor Knox, and Representative Eleanor Richardson were chosen.

The concept of a Community center was developed by Bill Denton of the South Decatur Council. The buildings, he said, are historically significant, attractively designed, and have served as a real stabilizing force in the vicinity since they were occupied in 1920.

The concept proposal was approved by the Council more than a year ago; representatives of the Council have been working toward its realization ever since. Major space allocations would be made for community education programming and a community health center.

A federal community health center application is in final stages of preparation and negotiations are underway to bring the Decatur Health Center of the DeKalb Health Department into the building.

A major step, of course, is getting access to the property and negotiations are underway in this area as well. Representative Richardson, Dr. Davison Phillips, and Mr. Robin Harris have met with the executive committee of Scottish Rite and received expressions of interest in the community's proposal.

Ultimately, community access to the facility and realization of the proposal are contingent upon community interest and support for the project. In addition to the new services, the project should provide a focus for neighborhood development activities throughout the South Decatur area.
