Some of these races will be decided in the primaries (marked with an asterisk) however others will meet further opposition in the general election in November.




MANUEL J. MALOOF

I've been active in the Democratic Party at state and local levels for decades and served as Commissionerat-Large. For many years I served on various commissions for DeKalb County and was the first C. R. C. chairman. I have guest-lectured at all the area colleges. I have run my own business for 30 years.

WALT RUSSELL

Russell, a West Point graduate, was decorated for heroism in Korea and Vietnam. Retired for head wounds in 1966 as Lt. Col, he graduated from Emory Law School and began his own law practice. Elected to the State Legislature in 1970, he served three terms until his election as Chairman in 1976.





The Animal Control Officer for Decatur has had at least ten complaints of dogs attacking and killing cats in the neighborhood.

There appear to be two dogs one black and one white or tan.
At least two of the reports
described the dark dog as a labrador.
The white dog was thought to be part
shepard and was smaller than the
black dog.

The areas affected have been Adams/Mimosa/Avery/Winnona/Heatherdown. The officer hopes to pinpoint the exact area. All of the reported attacks were during the hours of ll:30 p.m. and 5:30 a.m. Jo Deck reported having seen the suspected dogs on the playground two weeks ago and the white one appeared sick.



ZONING CONTROVERSY CONTINUES

On July 7th, the City Commissioners approved the plan submitted by Wales Thomas & Assoc., Inc. for 334 and 344 South Candler.

Controversy has centered around the procedures which should be followed in the City's handling of an application for rezoning or for a planned unit development. Neighbors are additionally concerned about the potential drainage problems which might be created by this particular development.

The DeKalb Superior Court is now being asked to intervene in the dispute in a challenge to the City's interpretation of the zoning laws.







COMMISSION NOTES

The July 7th Decatur City
Commission meeting was the longest
on record. After much citizen comment the Commission voted unanimously to approve the Wales Thomas PUD plan. Next they approved the purchase of three-wheeled garbage collection vehicles and four motorcycles for the Police Department. The Barry Street storm drainage project was discussed and again postponed until the necessary funds become available. A resolution was then passed to apply for funds from UMPTA for development of the Central Business District. An ordinance was passed to ammend Decatur's tax ordinance to bring it in line with state legislation which raised interest on unpaid taxes from 9% per year to 1% per month. A bid was awarded to E.R. Partridge in the amount of \$5039 for uniforms for the sanitation and motor maintenance departments.

The July 21st City Commission meeting began with the authorization of sale of properties at 135 Mead Road and 326 Hill Street. It was not agreed how proceeds of the sales would be utilized. Next the Commission authorized a suit against DeKalb County for failure to implement Amendment 76 which prohibits double taxation. The Decatur Tax Payers League may have to draw up the suit. Commissioners voted to ammend the 1979-80 budget to show increases in expenditures and income. Due to some disorderly conduct in city parks at night, the Commission voted to close the parks from 11:00 p.m. until 7:00 a.m. It was then agreed to remove a footbridge, originally built by the city, at the end of Greenwood Place because it has become a focal point for noise and crime and is considered a nuisance to neighbors. A citizen asked why the homestead exemption for the elderly in Decatur is only \$5,000 compared to the \$8,000 permitted by the County.
