#### DECATUR CITY ELECTIONS Candidates and Issues

The City Commission of Decatur is composed of five members and is the only elected board in the City. Two contested races will be voted for on Wednesday, December 3. Voters will choose between Bob Carpenter and Lyn Deardorff and also between Lew Ballard and Ted O'Callaghan. On November 20, the Decatur Neighborhood Alliance held a forum where citizens could question the candidates.

General Remarks
Carpenter - Bob Carpenter emphasized his roots in the city -25 years residence and 10 years on the Commission. He stated that following the ill feelings generated by last year's development plans, the Commission had taken steps to put it back in touch with the community, including opening its work sessions to the public for the first time. He denied allegations that he was persuaded to reverse his decision not to run again by persons with special interests in downtown development, or that such persons would improperly influence his decisions. Overall, he was proud of his record on the Commission.

Deardorff - Lyn Deardorff emphasized her efforts on behalf of citizens' input in Decatur concerns, including her prominent roles in the Downtown Redevelopment Task Force, the 1979 Transportation Task Force, the Decatur Neighborhood Alliance, the Winnona Park Neighbors' Association, Historic Decatur, the recevelopment of old Scottish Rite into the new Community Center. She promised to bring a grass roots view to the Commission, both in procedure (e.g., giving more advance notice of Commission agenda), and through continuing her personal contact with neighborhood groups and citizens. She further vowed to keep close relations with the city merchants and stated that her management consultant background would qualify her to closely examine the budget.

Ballard - Lew Ballard spoke of his long-time involvement in city affairs, including his attendance upon City Commission meetings and his publishing of Inside Decatur. He stated that, if elected, he could not force the Commission to do anything but he could ask questions that are presently going unasked. He cited as an example the budget approval process where he said the past several budgets prepared by the permanent city staff have passed without revision or substantial examination. Decatur's only elected body, he said, needed to exercise closer supervision over the permanent city bureaucracy. In response to a personal attack from the floor for his placing his child in private school, he stated that his child suffered a learning disability and, as a father, he felt bound to follow professional advice and send her to the Howard School, which handles such problems.

O'Callaghan - Ted O'Callaghan asked the audience whether they liked living in Decatur. He suggested that Decatur's good points "didn't just happen", that the Commission sets the tone and flavor for what the city will be like and if you like the city, you should re-elect the City Commissioners. He also decried one-issue politics, which he felt was becoming too pronounced in city affairs.

Transportation - All candidates agreed on transportation issues, being against new major thoroughfares but in favor of non-obtrusive traffic improvements such as signalization, turning lanes, and the like.

Taxes - All candidates favored tax relief for the elderly, the challengers asking why more had not yet been done. The incumbents saw the primary prospect for relief in development expanding the tax base. The challengers pointed out that Decatur has the highest tax rate in the state and the highest rate allowed by law. With assessments likely to double next year, ending this limitation, they suggested that attention needed to be focused on controlling expenditures and not just on expanding the tax base. Deardorff favored a city homestead exemption.

Development:

Carpenter - Downtown development should be planned. Development will not necessarily just happen without encouragement from the city and concessions to what is acceptable to a top-drawer developer; not opposed to higher density development in residential neighborhoods; no problems expressed with existing zoning laws.


Deardorff - Development should be on an appropriate scale for Decatur and development of vacant land and rehabilitating existing buildings a first priority. High density residential development should be limited to commercial Revamp of zoning laws needed; need historic preservation of neighborhoods.

Ballard - Similarly favors organic development downtown. Development should use private monies. City Government and Structure - The incumbents supported Decatur's dual registration and at-large election of commissioners; the challengers favored the appointment of a citizens' task force to examine these issues and the overall structure of city government.





# COMMISSION

The October 20th meeting of the Decatur City Commission began with the recognition of two employees. Mrs. Ethleen (Susie) Wages has worked in the Police Department for 25 years. Mr. Mac Arnold has been with the Sanitation Department for 15 years.

Acting on a recommendation of the neighborhood traffic studies, it was agreed to construct speed diminishers on Avery St. and on Sycamore St. as a pilot project.

The recommendations made by the Small Cities Community Development Program were adopted without change. The creation of the E. Lake MARTA station resulted in the formation of a new and yet unnamed street. This small street forms an arc from E. Lake Drive to College Ave. Suggestions for possible names were requested.

At the work session preceding the November 3rd Commission meeting, the four potential sites for the replacement for the old Ebster pool were discussed. The possibilities for use of MARTA parking lot (corner of Church St. and Sycamore St.) for metered parking were considered.

At the regular meeting the Commission pondered the problem of voter registration - whether or not to retain lists separate from the County lists of registered voters.

At the work session prior to the November 17th Commission meeting, Mr. Williams presented Decatur property reassessments and told how these reassessments were derived.

Next on the agenda was the swimming pool site selection. A tour of four possible pool sites by Commission members and three Beacon residents had preceded the meeting. At least seventeen residents of the area encouraged the adoption of Site 2 (Ebster Park). The Commissioners agreed to this site for the pool.

The Commission agreed to an increase of \$3,728 in the cost required to complete the Lower Sugar Creek Retention Pond (South Decatur area).
