#### EAST-WEST CONNECTOR THREATENS AGAIN

The spectre of an east-west connector (i.e., I-485, the Stone Mt. Freeway, Decatur Parkway, etc.) has become an issue once again. Apparently, several groups (of which D.O.T. is not the least) have attempted to tie together the Carter Presidential Library and an east-west road. I, along with many people, believe that the road and the library are not the same issue. Atlanta can have the library in the Great Park area without the road as recent studies have shown.

The City of Decatur and its citizens have been long-standing in their opposition to an east-west connector that creates and dumps traffic into Decatur and its neighborhoods. With declining traffic counts on present east-west corridors, we do not believe in spending the many millions required to build a road that would duplicate present highway corridors and the The damage caused to the MARTA line. affected neighborhoods by an additional road would be significant and would result in a lessening of that illusive, yet real, intangible quality of life.

We hope that the Carter Presidential Library will be located in Atlanta as we believe that is where it belongs. The Great Park area appears to be a good location with more than adequate access. An east-west connector and the Presidential Library are two separate, distinct issues and should not be tied together.



#### Dear Pres. Carter:

Our neighborhoods have worked for many years to find constructive uses for the Great Park land. We supported the work of the Great Park Authority which recommended using a portion of the land for the proposed Jimmy Carter Presidential Library. The Library, however, does not require the construction of an otherwise unneeded commuter 4-lane roadway across the Great Park land.

We urge you not to connect the Carter Library to highway construction. The decision to build the library, with appropriate access streets, can be based on its own merits. We cannot support a 4-lane parkway as an access road.



# LEGISLATIVE HIGHLIGHTS



#### reapportionment

Under the new reapportionment plan (if approved by the Justice Dept), Winnona Park will remain in Senate District 55 now represented by Bud Stumbaugh. In the House, Winnona Park would no longer be diveded between the 52 and 53 districts but would fall into District 52 now represented by Eleanor Richardson.

#### emergency aid

Rep. Eleanor Richarson reports that an emergency bill has been passed by both houses & signed by Gov. Busbee which will replace 7 and one-half million dollars of funds cut Nov. 1st for medicaid patients in nursing homes.

#### sunshine law

Senator Bud Stumbaugh has introduced a constitutional amendment which would make the 1972 Sunshine Law applicable to all legislative general assembly meetings. This would include special sessions, study committees, conference meetings and committee meetings. The amendment would allow the public to be present at these meetings unless both houses passed a specific law to the contrary. Sen. Stumbaugh says the amendment is expected to pass the Senate soon and will go to the House sometime in mid Feb.

#### sentencing alternative

Sen. Stumbaugh, along with two Cobb Co. senators, introduced a bill, now passed by the Senate, which will provide another alternative in sentencing in capitol offense cases. Currently there are two choices — life imprisonment with parole a possibility and the death sentence. This bill would add a 3rd choice — life imprisonment with no parole. Similar bills were introduced in the House, so some version will probably pass.

#### auto inspections

Auto safety inspections will no longer be required in Ga. when the final version of the law is passed this year.

#### DOWNTOWN DEVELOPMENT

The Downtown Development Task
Force will hold its third public
hearing on Tues, Feb. 9th at 7:30
p.m. in the cafeteria at Renfroe
Middle School. At this meeting the
planners will present preliminary
architectural and urban designs
and alternatives along with support
documentation for the redevelopment
of the downtown area. This should
be a very informative meeting -- be
sure to mark it on your calendar.

Here's some background on these meetings:

After a huge public uproar over the last plans for redevelopment, a citizen task force headed by Lyn Deardorff (S. Candler) was appointed by the city to look into the problem of revitalizing downtown Decatur.

The Task Force heard presentations from several development teams, ultimately selecting the Decatur Square Development Team to draw up a proposal for redevelopment.

The process is to take 6 mo. and includes a series of public hearings designed to get maximum input from Decatur citizens.

The first of these hearings was an orientation meeting in Nov., 1981, where about 60 to 70 people generated ideas in a "brain-storming" session.

In Dec. the second public hearing was held. This one took the form of workshops on specific issues: economics and marketing, parking & traffic and the image of downtown Decatur. It was attended by 80 to 90 Decaturites.

The Feb. meeting referred to above will the third hearing in which the public is invited to actively participate.


After each public hearing, the Task Force and neighborhood representatives meet to discuss and assimilate the information & ideas brought out by the citizens. Winnona Park's representative is Jo Deck, current pres. of WPNA.

Hopefully, the outcome of this process will be a plan for downtown Decatur with which we can all live.
