

#### CHURCH STREET **HEARINGS BEGIN**

The next chapter in the Church Street Widening issue began unfolding as the first in a series of public hearings was held July 15th at the new police department.

In spite of the rainy weather, between 50 and 60 people from all over Decatur showed up to express their concern over the specter of a four or five-lane highway.

Their fears are well-founded. D.O.T. policy, as explained by the planner hired by the city to conduct these hearings, is to build either a fourlane highway with a ditch beside the road (ie, no sidewalks, no bike paths, etc.) or a five-lane highway with all the trimmings.

No one spoke favorably of widening Church St. Concerns expressed by the citizens included:

- 1) the fact that the widening of Church St. would destroy a section of a Decatur neighborhood;
- 2) the impact on use of the swimming pool, tennis courts, and park facilities at Glenlake Park;
- 3) the impact on the Clairmont Grammar School (which would wind up adjacent to the road);
- 4) the impact to the rest of the neighborhood from the increased traffic such a road would attract (safety, noise, traffic on side streets, etc.);
- 5) whether such a road would be destructive of the quality of smalltown life that many enjoy in Decatur; 6) whether such a road is really necessary for downtown development; 7) and whether those who would benefit by such a road are those travelling through Decatur (to downtown via Howard St.) and not to Decatur.

Decatur's options, ranging from "doing nothing" to widening Church Street to a five-lane highway, will be the subject of a series of hearings. The dates of the hearings have not yet been announced but will be published in the Newsletter if we get them in time.

As City Manager, Curtis Branscomb says, this is a "gut issue" for Decatur and we should all participate. Many thanks for Commissioner Marian Cunningham's attendance -- she was the only commissioner present.






#### IN MEMORY OF AL



#### Decatur Civic Chorus

The Decatur Civic Chorus, a non-profit community organization, was founded in 1948 and is one of the oldest continuing choral groups in the Southeast. Its membership is composed of families, married couples, and individuals with professions such as: teachers, lawyers, doctors, nurses, pilots, choir directors, salesmen, computer programmers, housewives, etc.

Noted for its community service, the Chorus has received recognition on State, National and International levels. The Decatur Civic Chorus has performed at the Governor's Mansion and was proclaimed an Official Bicentennial Chorus by the Georgia Chamber of Commerce. National honors came in 1976 when the Chorus was commended for its part in creating good international relations by one of Georgia's Representatives in the House. This speech was recorded in the Congressional Record. Later, in 1971, the Chorus received a personal letter from the President of the United States congratulating them for their contributions in helping their fellow International recognition has come to the Chorus through three European tours. The group has participated in International Music Eisteddfod in Wales on two different occasions, and in 1978 was chosen to represent the United States in an International Music Festival in Spittal, Austria.

Versatility is demonstrated in the wide range of the Chorus' repertoire. The group has given annual concerts for over thrity years adn has performed on radio, T.V., and with the Atlanta Symphony, and has sung for many organizations such as the American Cancer Society, Scottish Rite Hospital for Crippled Children, Veteran's Hospitals, Stone Mountain Park, and Georgia Retardation Center. Equally at home with classical and folk music, the Decatur Civic Chorus concerts contain something for every musical taste.


