### DECATUR CITY ELECTIONS

The only elected officials in the City of Decatur are the five at-large commissioners who serve two year terms. Elections for 3 of the 5 seats will be held on Wed., Dec. 1st.

Although no candidates had formally qualified to run at the time this newsletter went to press, two individuals have publically announced their candidacy: Wes Saunders (Adams), past president of Decatur Neighborhood Alliance, and Louise Thrower (McDonough), neighborhood leader in the Oakhurst area. There have also been rumors that Brad Glenn, owner of Conversations Restaurant in Decatur, is also considering running. It is assumed that incumbents Bob Carpenter, Ted O'Callahan and Candler Broom will try to retain their seats.

In the past, Decatur had a dual registration for voting -- one for county, state & national elections and one for city elections.

This has been changed and dual registration is no longer the rule. Now, you register once for all elections. In addition, all those who were previously registered only in the county (and who therefore could not vote in Decatur elections) have been added to the Decatur list. This increased the number of registered voters in Decatur by approx. 5,000.

Usually you vote in the elementary school in your area -- if you are not sure, check with City Hall at 377-9911.

If you are not registered in either the county or the city, it is not too late.

The deadline for registering is Nov. 11.

#### THROWER ANNOUNCES CANDIDACY

Louise Thrower, Foreclosure Prevention Specialist for the Decatur Housing Authority for the past two and one-half years, has announced her candidacy for the City Commission.

A neighborhood leader in Decatur, Thrower was president of the South Decatur Community Council for three years, is on the Board of Directors and is currently serving as 1st vice president of the South Decatur Community Center, Inc., and is on the Board of Directors of Trinity Child Development Center.

She is a member of Lily Hill Baptist Church where she sings in the choir and is secretary and supervisor of the Youth Usher Board.
Recently, she was elected to the DeKalb Democratic Party Executive Committee.

Louise lives on McDonough with her husband, Leonard, and their daughter, Trina.

# SAUNDERS CANDIDATE FOR CITY COMMISSION


Wes Saunders, Adams Street resident, has announced his candidacy for the Decatur City Commission.

# WIDEN CHURCH STREET?

Background

The City Commission has been considering a proposal to widen Church Street from two to four lanes (5 lanes at intersections & from the city limits out to Scott Blvd). Before the Commission makes the final decision, a series of public hearings will be held to determine the extent of impact on Decatur and its neighborhoods.

The first four of these hearings are being conducted by George Eichler, a consultant hired by the City, who will then make a recommendation to the Commissioners. Three of these four meeting have been held and public response expressed by Decaturites at those hearings has been over-whelmingly against the road widening, although not adverse to intersection improvements.

A plan for the four lane which is being prepared by D.O.T. (the Department of Transportation), will also be presented to the Commissioners who will then conduct a further public airing of the proposal.

The Third Public Hearing
The 3rd public hearing on Church Street
was held Oct. 21st

Present at this meeting was a representative from D.O.T. who answered questions regarding their plans. He told the audience that D.O.T. is currently working on plans for a Church St. 4-lane from E. Ponce de Leon to Medlock and for a 5-lane on out to Scott, with the primary consideration being given to "the person who pays for the gas".

As with other meetings, Decatur residents voiced concerns over the impact such a highway would have to the area and to the city:

- 1. A trustee from Clairmont Oaks asked that the safety of the approx. 300 elderly residents be considered, particularly since many of them use the area as pedestrians;
- 2. Decatur attorney Bob Leitch expressed concern over 'spot widening' on Church Street without consideration of the overall Decatur traffic situation, especially in light of the previous transportation task force recommendation that intersection improvements be tried first. Leitch further warned that such road widenings are often accompanied by an increase in crime in the area;
- 3. Another major issue involved land use of the property adjacent to the highway, which would no longer be suitable for private homes. Cathy Reader (Landsdowne) pointed out that it would be almost impossible to keep out commercial development on the Decatur portion of Church St. when the county portion would almost certainly be commercial;
- 4. A resident of Ponce de Leon Court was concerned that traffic at the intersection of Columbia Dr. and Church St. could worsen given the already heavy traffic flow from Clairmont and the almost certain increase of use of Church St. if the widening goes through;
- 5. Some discussion also covered the question of whether widening Church St. would serve those in Decatur, those coming to Decatur or those going through Decatur. Objection was again made to the lack of origin/destination studies which could show the use currently being made of the road. The only studies available are yearly traffic counts (which show a declining usage over the last 5 yrs).

The date of the fourth hearing had not been announced when we went to press.

# COMMISSION

The October 4th meeting of the Decatur City Commission began with the awarding of 15 year service pins to Fire Chief Sherrard White and Maintenance Chief Willie Carr.

However, the issue of the meeting which created the packed house "plus" was the establishment of the Downtown Development Authority and the appointment of members. The appointments made were Peter H. Giles, pres. of Simons Eastern; Mrs. Floyd Sanders, civic leader; Robin Harris, pres. of Decatur Federal; Grady Baker, v.p. of Georgia Power; Walt Drake, former mayor and attorney with McCurdy & Candler Law Firm; Jim Philips, exec. v. pres. of Draper & Owens (banking & real estate) and Dr. Ruth Schmidt, new pres. of Agnes Scott College.

The audience consisted mainly of merchants of small downtown Decatur businesses and neighborhood activists, most of whom were concerned about the fact that none of the appointees represented either of these two groups. Mayor Carpenter commented that he thought Decatur had grown beyond the old days, referring supposedly to the split and disagreement resulting from the Hines Zuchelli plan of several years ago. He commented that all of the appointees are neighbors to somebody. Commissioner Mealor mentioned the possibility that Dr. Schmidt, who lives on Agnes Scott property, may not have paid city taxes and therefore would be ineligible to serve on the Authority. Several members of the audience urged the Commission to appoint Lyn Deardorff (S. Candler) in her stead. Mayor Carpenter killed the debate and the appointments were made with reservations. Commissioner Cunningham voted against the appointment and Mealor abstained.

The official call for the Dec. elections was then made. Commissioners Broom, Carpenter, and O'Callahan's seats are up for reelection. Qualifying closes Nov. 16 and election day is Dec. 1 with voter registra-

tion closing on Nov. 11.

At the Oct. 18th City Commission Meeting Lyn Deardorff was appointed to replace Dr. Schmidt on the Downtown Development Authority.

Commissioner Cunningham reminded those present of the amendment to be voted on Nov. 2 concerning the homestead exemption accepted by the city. This is an across the board \$2,000 exemption. At the discretion of the Commission, this exemption can be raised to as much as \$10,000.

The double taxation issue was discussed. Mayor Carpenter said that the meetings with the county have not borne fruit. The Child's bill which will force the issue will go into effect in March, 1983. This bill provided that Decatur residents will pay only 34% of the county levy. The County still has recourse but the municipalities are ready to fight.


